An application fee of US \$75.00 is required with the application form. If the I-20 is to be sent to home country address, please enclose **additional \$ 100.00** for I-20 Filing Fee. The application fee and I-20 Filing Fee (if applicable) must be paid by credit cards, international money order, US bank check, or traveler's checks. **PLEASE DO NOT SEND BANK DRAFTS**. This fee will **NOT** be deducted from the tuition fee of \$6,800.00 upon enrollment, and will **NOT** be refunded if the student does not enroll. A minimum of **FOUR MONTHS** of attendance in LearnNet is required. Exceptions will be made only for transfers to college or university and for students returning to their home country after attending for four months.
